- 2.5. **“EME”** means an Exempted Micro Enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- 2.6. **“Functionality”** means the ability of a tenderer to provide goods or services in accordance with specifications as set out in the tender documents.
- 2.7. **“prices”** includes all applicable taxes less all unconditional discounts;
- 2.8. **“proof of B-BBEE status level of contributor”** means:
  - 2.8.1. B-BBEE Status level certificate issued by an authorized body or person;

#### 1. PURPOSE

The WRC wished to appoint a services of a professional space planner to map the current size and space of a portion of the WRC's office and provide with the necessary details and documentation for the construction requirements needed to fulfil the 2<sup>nd</sup> floor reconfiguration for the Research Managers' office spaces
