#### **1. BACKGROUND AND INTRODUCTION**

The Water Research Commission (WRC) is a national entity established in terms of the Water Research Act (Act No 34 of 1971), to coordinate and fund water research in South Africa.

The WRC requires to appoint a service provider for providing courier services for a period of thirty-six (36) months

#### 2. SCOPE OF WORK: REQUIREMENT/SPECIFICATION

The WRC requires to appoint a service provider for providing courier services for a period of thirty-six (36) months to the WRC as follows.
