The Water Research Commission (WRC) is a national entity established in terms of the Water Research Act (Act No 34 of 1971), to coordinate and fund water research in South Africa.

The Water RDI website service was procured and went online on the 1st of June 2021. This website provides a platform for sharing information on the roadmap with stakeholders in the water sector and the National System of Innovation.

2. SCOPE OF WORK: REQUIREMENT / SPECIFICATION

- Maintain and host the already existing Water RDI website that contains all the relevant information provided in the specification document.
- Training to be offered as part of handover once the website development is complete
- All the relevant documentation relating to system design (databases, content, passwords, architectural diagrams, backend code, etc....) to be handed over once the website development is complete
- Hosting and support of the website and all associated is required for a period of twenty-four (24) months
- Develop and document the architecture of the website Link to the website: https://waterroadmap.co.za/
