1. BACKGROUND AND INTRODUCTION

The Water Research Commission (WRC) is a national entity established in terms of the Water Research Act (Act No 34 of 1971), to coordinate and fund water research in South Africa.

The Water Research Commission operates out of a building in which the structure and the application of processes are environmentally friendly and resource efficient (Green Building). Due to the WRC's office space being within a building that is considered to be a "green building", the workmanship, choice of materials and any other contributing elements need to be conducted/provisioned/done in a manner that is compliant to the standards defined within this.

NB: Any bidder who did not sign and submit any of the requested documents may be disqualified.

Service providers who comply with the requirements will be evaluated under Price and B-BBEE phase to determine the highest scoring bidder for recommendation.



9. PRICING
