### 1. BACKGROUND AND INTRODUCTION

The Water Research Commission (WRC) is a national entity established in terms of the Water Research Act (Act No 34 of 1971), to coordinate and fund water research in South Africa.

The WRC requires to appoint a service provider for the provision of SIP trunk/ voice call charges service for a period of twelve (12) months

### 2. SCOPE OF WORK: REQUIREMENT

The WRC requires to appoint a service provider for the provision of SIP Trunk / Voice Call charges service on a 12-month contract as follows.

- Sip Trunk installation
- Porting of all current numbers
- · Billed monthly voice minutes.

# Scope of work

- 1. SIP Trunk installation (50 concurrent calls), configuration, and testing
- 2. Call costing (for both fixed lines and well as mobile for local & international)
- 3. Must operate with current Mitel PBX solution
- 4. Must integrate with current TNG telephone management system.
- 5. Porting of all numbers (switchboard and individual extensions) must be completed by selected provider.
- 6. 12 (twelve) months support with a dedicated Account Manager assigned
- 7. Setup / configuration cost of the Mitel PBX controller to the trunk must be included.
- 8. Must be implemented before end of July 2022

### 3. EVALUATION PHASES

The received proposals will be evaluated in different phases in order to arrive to the final phase of bid award, and the phases will be as follows:

- 3.1 Phase One Screening of the minimum requirements documents
- 3.2 Phase Two Pre-qualification
- 3.3 Phase Three Specification compliance
- 3.4 Phase Four Price and Preference (B-BBEE)



# 3.1 Phase One (01): Screening of the minimum requirements documents

In this phase All bids received will be verified for compliance and completeness of the submitted proposal per the below set of mandatory requirements. # 3.4 Phase Four (4): Price and Preference (B-BBEE) Evaluation

Service providers who comply with set pre-qualification evaluation requirements will be evaluated under Price and B-BBEE phase.
