PART D TERMS OF REFERENCE / SCOPE OF WORK

1. BACKGROUND AND INTRODUCTION

The Water Research Commission (WRC) is a national entity established in terms of the Water Research Act (Act No 34 of 1971), to coordinate and fund water research in South Africa.

The WRC requires to appoint a service provider for the upgrade and installation of the current RUCKUS WIFI equipment

2. SCOPE OF WORK: REQUIREMENT

The WRC requires to appoint a service provider for the upgrade and installation of the current RUCKUS WIFI equipment as follows.

WRC implemented a RUCKUS WIFI solution in 2016. This solution has become outdated, and the ailing technology is no longer servicing the needs of the organisation. The external network audit report also found that the technology does not meet the current required security standards. The current hardware is no longer covered by any warranty. It has become necessary for the equipment to be upgraded to the latest technology available from RUCKUS. This will allow for enhanced security, updated guest access configurations, analytical capabilities, and better overall performance.

Quote must meet the specification as follows:

- 10 X AP's (Access Points) Ruckus R350 dual-band 802.11abgn/ac/ax Wireless Access Points, 2x2:2 streams (2.4GHz/5GHz) OFDMA, MU-MIMO, BeamFlex+, 802.3af PoE support. Does not include power adapter or PoE injector. Includes Limited Lifetime Warranty
- Secure Mounting Bracket for Ruckus R720, R710. Mounts to hard wall/ceiling, pole, and truss.
- Virtual SmartZone 3.0 or newer software virtual appliance, 1 Instance.
- Specialist Partner Support vSZ-RTU, 3 Year
- SZ AP Mgmt License for SZ144/vSZ, including 3yr support and RUCKUS Analytics Subscription 3yr.

The Solution should also include the following:

- (1) Setup of Virtual Smart Zone, WLAN, AP Zones
- (2) Setup and Segmenting of Wlfi Networks (Guest, mobile, staff)
- (3) Staff setup must be integrated with Active Directory to allow better security
- (4) Decommissioning of old Access Points
- (5) Installation of new Access Points
- (6) All travel, sundries, project costs, management
- (7) All documentation and configurations must be handed over to WRC on completion of the project

3.3 Phase Three (3) - Specification compliance
