

The WRC requires services of a carpentry company to repair 11 desks on both 2nd and 3rd floor and to repair 2nd floor kitchen. The 2nd floor kitchen was damaged by water during pipe bust.

2. SCOPE OF WORK: REQUIREMENT/SPECIFICATION

The objective of this request for quotation is to invite professional service providers to submit quotations for consideration, to be appointed for the repair and installation of locks on the WRC' open floor desk and 2nd floor kitchen unit.
