

1. BACKGROUND AND INTRODUCTION

The Water Research Commission (WRC) is a national entity established in terms of the Water Research Act (Act No 34 of 1971), to coordinate and fund water research in South Africa.

2. PURPOSE

The purpose and scope of the assignment is to appoint a service provider to locate an individual who had stolen items from the WRC

3. SCOPE OF WORK: REQUIREMENT/SPECIFICATION

The objective of this request for proposal is to invite service providers to submit proposals for consideration, to be appointed tolocate an individual who had stolen items from the WRC. The appointed service provider will be required to cover the following:

Geographical area where the service will be provided:

• The WRC has the known individual's address, though the individual might have relocated to a different address or location around South Africa, therefore, the supplier search should not be limited to Gauteng only.

Description of Goods / Services:

- The appointed company is expected to track the whereabouts of the individual in question.
- Once the individual has been found, the company is expected to give the location to the WRC who will then inform the law enforcement (the police) to locate and apprehend.

3. EVALUATION PHASES

The received proposals will be evaluated in different phases in order to arrive to the final phase of bid award, and the phases will be as follows:

- 3.1 Phase One Screening of the minimum requirements documents
- 3.2 Phase Two Specification compliance
- 3.3 Phase Three Price and Preference (B-BBEE)

3.4 Phase Four – Due-diligence to ascertain if the highest scoring bidder has the right skills and expertise in line with the scope of work.

3.1 Phase One (01): Screening of the minimum requirements documents

In this phase All bids received will be verified for compliance and completeness of the submitted proposal per the below set of mandatory requirements. Bidders who fail to comply with the below requirements may be eliminated and bidders who comply with the below progresses to the next phase of technical evaluation.

- Bid forms must be properly received on the bid closing date and time specified on the invitation, fully completed, dated.
- Invitation to Bid (SBD 1) must be fully completed.
- Submission of a Valid SARS Tax Clearance Certificate together with Supplier SARS Tax Compliance Status Verification PIN to enable Water Research Commission to verify Tax Compliance status on SARS eFiling. NB: Bidders whom their Tax matters are not in order will not be considered for this bid.
- Submission of fully completed SBD 4 (Declaration of Interest).
- Submission of fully completed SBD 6.1 (Preference Claim Certificate).
- Submission of the original or certified B-BBEE Status Level Verification Certificate or original B-BBEE Sworn Affidavit in case of EME and QSE).
- Submission of Central Supplier Database (CSD) Compliance History Report.
- Provide at least (2) contactable references letters where similar assignments were undertaken.
- Provide CVs of the team who will be working on this project if your company is successful.

3.2 Phase Two (2): Specification Compliance

Service providers submitted price quotations / proposals will be checked against the specification to ascertain compliance. Service providers who fail to fully comply with the specification requirements will be eliminated.

3.3 Phase Three (3): Price and Preference (Specific Goal) Evaluation

Service providers who comply with the set minimum threshold will be evaluated under Price and Specific goal phase to determine the highest scoring bidder for recommendation.

3.5 Phase Five (5) – Due-diligence



The WRC reserves the right to invite the highest points scoring bidders per the outcome of phase three (Price and preference points (specific goals) for a meeting with the WRC project owner and any other relevant WRC representatives as identified by the project owner, for the purpose of testing and ascertaining whether the proposed official/s who will be working on this project has the relevant skills and experience suitable for this project (scope of work).

Service providers are advised that the WRC will only contact the top three highest scoring bidders for duediligence, starting with the highest scoring bidder, while the second and the third highest scoring bidders will only be invited for a due-diligence meeting if the outcome of the highest scoring bidder confirms that the supplier does not have the WRC expected level of skills and experience.

The WRC reserves the right not to appoint the highest points scoring bidder/s if the outcome of the due diligence if conducted by the WRC project owner and any other relevant officials confirms that the proposed officials does not have the expected level of skills and experience suitable for this project.

4. PRICING

The RFQ will be evaluated on both Price and Specific goals points scoring system and the service provider who obtain the highest points and fully meet with the specification requirements.
